Minutes of the meeting held on 8th September 2010

1. Present

3. Approval of minutes from last meeting

The minutes from the June meeting were approved and signed by C.Roy (Chairperson).

4. Matters Arising

i. Actions Intimated

- ❖ Local Housing Strategy Housing Issues Report J.Skabara (Secretary) had responded on behalf of FCC after requesting comments – copy attached. A reply had been received thanking FCC for their response.
- Delivery of information
 - Fintry School Bus J.Skabara had e-mailed Colin McMenemy (Planning & Performance Officer, Education Business Support Team) to ask if there were spaces on the mini-bus that could be filled by children currently being expected to walk the dangerous route to the Clachan end of Fintry. C. McMenemy had replied to say that he was unable to say if there would be any spaces but if there were, parents could apply for a concessionary space. J.Skabara to inform relevant parents suggesting they apply for a concessionary space to see if there are actually any spaces. J.Skabara to also inform Julie McEachern (Chairperson, Balfron High School Parent Council) that P.C.McNally is willing to walk the route to establish its safety.
 - Denny Road J.Skabara had e-mailed Carron Valley Community Council to ask if we could combine our efforts to get the Denny Road gritted. A reply was received to say that they would help out but it was agreed that we should wait until the new Larbert hospital opens.
 - Road Budget J.Skabara had e-mailed Les Goodfellow (Head of Transport & Open Spaces) to express FCC's disappointment in the removal of £1 million from the roads budget. A reply had been received from Jamie Wright (Roads Maintenance Manager) outlining the money that had been spent improving the roads in and around Fintry in the last year. Cllr O'Brien reported that pounds from roads resurfacing had gone to works at the former Killdean market site.
 - Minutes of Rural South West Area Community Planning Forum had been forwarded to M.Duckworth.
 - A poster advertising Stirling's Armed Forces Day had been displayed in the FCC notice board.
 - A Stirling Carers Connection leaflet had been given to J.Cuthbertson.

- ❖ Parking at the church P.C.McNally will have a look at the problem and suggest safer ways to park and speak to Hugh Edmonds (church officer).
- ii. <u>Fintry Bridge & Spout Burn bridge</u> The footway on the Fintry Bridge has a section missing J.Skabara to inform Ian Young (Team Leader, Bridge Maintenance & Flooding). There are rotten planks on Spout Burn Bridge which need replacing C.Roy to contact Willie Hamil.

iii. Fintry Sign

The sign has been stolen! P.C.McNally to investigate and C.Roy to check if FCC insurance would cover its replacement. C.Roy also reported that the Culcreuch Avenue road sign had fallen off and that she had contacted the relevant person about it but received no reply. C.Roy to forward the information to Cllr O'Brien to follow up.

<u>6. Councillor's Report</u>

Cllr O'Brien reported that things had been quiet over the summer. In preparation for the winter, Cllr O'Brien was hoping to persuade Stirling Council to place large quantities of grit in each village so that there was a ready supply for villagers to use and/or to restock the smaller grit bins. Cllr O'Brien wanted to make everyone aware that national budget and spending cuts will eventually work its way down to community councils and individuals. There could be £30 million worth of cuts for Stirling Council next year which could mean less funding available for community councils and community councils and may lead to an increase in Council Tax.

Local Housing Strategy Housing Issues Report Response

1. Housing Needs & Demand

Proposed Outcome: A good range and choice of housing, including affordable housing

Housing need

1.1 How do we prioritise amongst the range of housing needs that exist?

It seems clear that more low cost housing is needed and Council houses. The increasing number of people aged 65+ and the increase in single person households indicates a need for small, affordable houses.

1.2 How do we identify and secure appropriate housing sites?

It would be good to expand some of the smaller villages but a good infrastructure of public transport, shops and health facilities would have to be ensured.

1.3 How do we secure the infrastructure required to develop housing sites?

Ensure that existing services continue. Maybe make it a condition for developers to put money into improving the local infrastructure.

1.4 How do we ensure that new homes meet the needs of an ageing population?

Small affordable houses with small, easily maintained gardens as well as easy access to shops, health services and public transport. The housing needs to be big enough for a carer if/when that became necessary. More sheltered housing or co-housing.

1.5 How do we create a more 'balanced housing market' ie more choice between sectors, stable prices and housing supply which is better matched to existing needs & demands.

Keep up the rate of building if not actually increase it. Make sites attractive to housing developers.

1.6 How can the supply of affordable housing be increased; is there a role for low cost home ownership?

There is definitely a role for low cost home ownership and shared purchase options.

1.7 There is a need for more supported accommodation for vulnerable households.

Co-housing could be an option.

Privat e rented sector 1.8 How do we improve conditions in the private rented sector?

Clamping down on unlawful premiums. Give landlords some protection from problems which may arise from having DSS tenants.

1.9 How should the access of low income households to the private rented sector be improved?

As above.

1.10 Is there a role for houses at Mid Market rents? Yes, it's important to have all types of housing available.

Proposed Outcomes: A high quality environments, both built and natural; A commitment to sustainable development in our communities and across partner activities; Maximised income & minimised poverty (including fuel poverty).

Climate change & energy efficiency

Planning conditions MUST NOT allow houses to be built that use fossil fuels. The use of ground/air source heat systems, solar panels, photo-voltaic panels and wood fuelled systems MUST be encouraged.

Response to Main Issues Report

On the whole we agree with the Preferred Approaches to the challenges addressed rather than the Alternatives Approaches as set out in the Main Issues Report. We are restricting our response to consideration of Spatial Strategy agreeing with the overall approach as set out on pages p71 and p82. Of the '3 issues under consideration for the rural villages' (p68): issue 1/2 - we support widening the choice not restricting the housing type, though the need for affordable and small houses, being in short supply and particularly suited to the young and old, is undoubtedly a priority. Issue 3 - small-scale business in the rural area is often achievable from home reducing the need to asign areas for business premises

Comments on Appendix A – Fintry

Under 'Settlement Assessment - Character and Identity' it should be noted that the Endrick is not simply SSSI but is also designated as a Special Area of Conservation.

The rest of the assessment including the pros and cons under 'Suitability for development' are fairly assessed, but we would like to stress our continuing concern in respect of the capacity of the Fintry WWTW while suggesting that septic tank systems may offer a solution.

We are not in favour of the Council's adopted policy of adding houses to very small Building Groups as defined in H10A which could lead to many scattered groups of houses in the countryside but prefer development within Small Settlements as listed in appendix A, Clachan of Fintry among them. In reality how available land is within the Small Settlements (as defined in Appendix A) may affect the usefulness of this alternative but appears a better way of allowing at least some development in the countryside.

MIR reference FINT.A and FINT.B (both FINT02 and FINT03): There are members of the Community Council and almost certainly many others who will not be in favour of these areas being accepted for future building but the document's assessment comments under all headings seems fair, and it is accepted that finding alternatives for some housing development is problematic.

Under Supplementary Guidance we would also like to emphasise the importance we attach to effective control of design for buildings and landscape, and of tree protection in developments 'in the countryside' (or in what until now has been so designated), and note your explanation of possibilities on page 83.
