

# Minutes of the meeting held on

20<sup>th</sup> April 2011

### I. Present

### III. Approval of minutes from last meeting

The minutes from the last meeting were approved and signed by C.Roy (Chair).

### IV. Matters Arising

- 1) Actions Intimated:
  - **i.** Communications:
    - a. Notices at Sports Club J.Skabara had displayed various posters and flyers.
    - b. Drains ongoing C.Roy to inform Stirling Council which drains are in need of clearing.
    - **c.** Road Danger ongoing P.C.McNally to report a member of the public's concern about the dangerous conditions of some of the local roads.
  - ii. Telephone Box C.Roy had established that the telephone box is still in a poor condition. J.Skabara to provide C.Roy with contact details to report this.
  - **iii.** Bank ongoing S.Kinnear and J.Hulme (previous Treasurer) to go to the bank to close the account. S.Kinnear to open a new account at the Post Office.
  - iv. Benches The plaque had not been fitted as the bench is in bad condition, as are all the village benches. C.Roy to look into getting help from Stirling Council Social Works Department through their Community Service Orders programme and S.Kinnear to look into the possibility of Community Pride Funding to pay for materials.
  - v. Bin bags Cllr O'Brien had followed this up and received a reply from Malcolm Roy (Land Services Protection Officer) to say that the placing of bin bags in lay-bys is not official practice and all staff would be reminded of the council policy.
- 2) Fintry Inn/FDT J.Pearson reported that the FDT were not proceeding with a feasibility study at the moment as someone local had expressed an interest in purchasing the Inn. J.Pearson also reported that the FDT were about to introduce a 'Car Club' 2 cars would be available for Fintry residents to hire. This is a pilot scheme funded by the Government. This information led to a discussion about the Demand Responsive Transport (DRT) service. Bert Comrie who works for DRT highlighted some possible changes to the service: the Friday service bus could change to a Wednesday; the DRT

service may be extended to Lennoxtown and to Fankerton to provide a possible link to the new hospital at Larbert; there was the possibility of a DRT vehicle being based permanently in Fintry; and Mr. Comrie hoped to produce some leaflets about the DRT which were specific to Fintry. Mr. Comrie also said that students at Balfron High School could use the DRT service to get to and from exams and if they provided a valid Pupil Journey Voucher (issued by the school) they would not have to pay a fare.

3) Consultations – There was some discussion on the 'Future of Policing in Scotland' consultation and the 'Future of the Fire and Rescue Service in Scotland' consultation. P.C.McNally gave some personal insight into the options proposed and the FCC agreed to indicate a preference for a rationalised regional force model which would involve the eight forces being reduced to three or four large regional forces. It was also agreed that the PACT system was a good model of local accountability and that this should be mentioned in FCC's response. J.Skabara to complete consultations and return to the relevant departments.

### V. Police Report

P.C.McNally reported that it had been quiet in Fintry although an unsecured agricultural vehicle had been stolen from a local farm. There had been an incident in Killearn in which a householder had agreed to have some holes in their driveway filled in for a nominal fee but had then been charged £2,500. P.C.McNally warned residents to make sure a price has been agreed before any work begins. P.C.McNally also reported that a recent incident in Kippen was <u>not</u> being treated as an attempted abduction.

Councillor Lambie Report

- Road Maintenance Inspection: I attended a roads inspection on Friday 18<sup>th</sup> Feb with 2 senior roads officers and Clir Jim Thomson (Pottfolio Holder Environment). The roads in question were specifically A&I1 (Stirling to Kippen), B&22 (Kippen for Infrury, B&I3 (Fintry to Boquina), Unclassified Road (Boquhan to S&22 (Kiper for Infrury, B&I3 (Fintry to Boquina), Unclassified Road (Boquhan to B&23 (Kaerfoyle to Kinochard), B&20 and A&I (Aberfoyle to Word Toli), B&35 (Ward Toli to Buchiyvie), A&II (Buchiyvie to Amronion), Bonda (Amprior to Port of Menteith), A&73 (Port of Menteith Blandrummod via Thornhill). The roads officers did agree that the B&I3 Killiam to Fintry was arguably the route with the most deterioration and a commitment was made to resurface significant sections of this south and the B&II Killiam to Fintry was arguably the route with the most deterioration and a commitment was made to resurface significant sections of this both directions and the new surface is a huge improvement. J will check with the roads department if they intend to white line this route. I am hoging we can continue this work to cover the remaining section of the B&I8 to Fintry and B&22 Fintry to Kippen. I have also requested another inspection trip to cover the A&II Bame Smithy to Strathibane, A&05 Carbeit to Croftamie, and C6 Balimaha to Rowardennan roads).
- Road Maintenance C10 New Line Road Closure: This had been timetabled for the first week of May. I understand this has been moved to the veek beginning <sup>30</sup> May. (Update for A pril Meeting: I have contacted Caron Valley -community council re. winter maintenance and re-surfacing on the BBIS Finity to berny. I have also passed on correspondence to Clir Scott Former, one of ward Clirs for the Stirling West Ward which shares the BBI8 with the Forth and Endnick ward). now
  - Reads Maintenance Forth and Endrick: There are current capital works at Allen Bend on the A811 near Buchiyue (Due to be completed before 4<sup>th</sup> May). I have also had an initial look at some possible future capital proposals including A81 Glengoyne to Strathblane, A809 Croftamie to Carbeth, A811 Amprior. (Update for April Meeting: Note: These are capital road restructuring projects which have been designed to improve road safety based on historic RTA (Road Traffic Accident) statistics, as opposed to revenue projects which would include resurfacing and pothole filling.   - Roads Safety Traffic Warning Lights: At the February budget additional resources have been allocated to road safety warning lights. At this stage 1 do not have specific details but will pass on any requests from communities as to type of sign and preferred location.

- Stirling Council Public Toilets and Comfort Partnerships: I have asked for an update on these from Ian Anderson (Assets Officer). There have been encouraging responses from communities including an innovative approach from Crianiarich who are looking to run the public toilets themselves. (Update for April Meeting: The officer has confirmed that to date there does not appear to have been expressions of interest from Fintry. I have not been contacted by any businesses/organisation in Fintry re. the abvove. ).
- re. the abvove. ). Sharad Working with Clackmannanshire Council: Both Stirlling and Clackmannanshire Councils have agreed to deliver Education and Social Services services jointly. This will mean that the Head of Education in Stirling (Belinda Greer) will be the Joint Head of Education and Deirdre Cilliers Joint Head of Social Services. There are substantial financial and efficiency benefits, which will accrue from this type of approach, and it allows good practice to be shared across the initiative is already seeing financial savings and efficiency improvements within the Education Service for example).
- Sewage Works and Burn: I've had previously contacted Alayne Findlay finlaya@stirling.og.u.k (Flooding Officer) re. on-going issues connected with the sewage works and the blocked burn. I've asked who is responsible for the clearin of the burn. (Update for April Meeting: This is proving to be tricky as I still do not know who is responsible for the burn below the bridge. I am hoping to progress this after May 5th).
- Demand Response Transport Fintry: This appears to be working well and I understand that other communities are interested in this type of provision.
- Glegoyne Distillery Car Parking: In late 2010 I met with the landowner to look at the problem with car-parking at Glegoyne Distillery. We looked at an area of rough parking on the Strathblane side of the distillery and opposite the main footpath to Dumgoyne. This would appear to represent a good opportunity to resolve some of the parking issues for both Distillery visitors and hill walkers. The car park site looks to be inside Killean CC area, whereas the summit of Dumgoyne is wholly within Strathblane CC area.
- Dumgoyne is wholly within Stationate CC area. Campsie Fells Regional Park: There is a working group looking at the potential of a Campsie Fells Regional Park. The group consists of representatives from the 4 relevant Councils East Dunbartonshire, Stirling, Falkirk and North Lanarkshire local authorities, Scottish Natural Heritage and Forestry Commission Scotland. The concept is similar to The Penthand Hills and Fife's Lomond Hills which were designated regional parks in 1986. (Update for April Meeting: There has been some consultation with communities e.g. Balfron Hijds School and there will be a related publication/guide launch at Mugdock Country Park on Tuesday 26<sup>th</sup> April. In my opinion the consultation needs to continue and I will be requesting that this issue is on the agenda for the next Area Forum meeting on 16<sup>th</sup> May)

- Road Safety: I have asked Alan Ogilvie to respond to a request for speed monitoring strips for Finitry CC. (Update for April Meeting: I did receive a response but need to check with Finitry CC if this has been done).
- Police Report: Following my previous CC meeting there have been, sadly, 2 road fatalities on the A811 near Kepculloch Farm between the A875 Balfron turnoff and Ballat Crossroads. And on the A898 near Finnich Gien. A51 understand it these fatalities may still the subject of a police enquiry. There is no apparent connection with the roadworks at Allen bend and the first accident. Also, two local police officers have been rightly commended for trying to save the life of the A811 driver prior to the arrival of paramedics. I also understand that members of the public along with local police assisted at the Finnich Gien accident.
- Planning: I have not received any communications re. planning applications in the Fintry CC area although I note there are have been a number of applications for the Fintry CC area in recent planning schedules.
- Planning: I understand that the planning department are working on a book of practical design guidelines to complement the Housing in the Countryside Policy complete with case studies, photographs, acceptable renewable energy adaptations etc. I have seen an early draft of this and I am hoping that this will provide an easy to use guide for Applicants, Objectors, Community Councils, elected members.

#### Stirling Council Budget – Summary Points

- Continuation of the Freeze on Council Tax.
- Continuing the winter maintenance programme, including the B822 near Fintry £150,000.
- Repairing roads following the worst winter in over 50 years £444,000 (on top of the Scottish Government funding of £326,000 making a total of £770,000 for winter roads repairs. (Note: This is in addition to the overall road maintenance budget).
